**When selecting this option, we will perform the services that specifically apply to your boat.**

Your boat will be unwrapped, sacrificial anodes replaced, the onboard systems commissioned, the motors and generator (if equipped) will be serviced, the exterior will be cleaned, waxed, compounded if needed and bright work polished. In addition, we will test the bilge pumps, navigation lights, motor compartment exhaust ventilation system, and horn. Below is a detailed description and cost of each commissioning service, and other services available to you.

### PAINTING

- Outdrive Painting**  
Apply antifouling paint designed for sterndrive applications to drive and gimbal assembly. .... \$250.00 ea.
- Trim Tabs**  
Paint Tabs using Sea Hawk Smart Solution metal free ablative Antifouling paint ..... \$75.00

### WINTER COVER AND CANVAS

- Shrink Wrap Removal/Recycling (See Note #4)** ..... \$4.00 ft.
- Canvas Installation (See Note #7)**
  - Bimini top..... \$90.00
  - Sport boat enclosure..... \$165.00
  - Bridge boat enclosure..... \$200.00

### BATTERIES

- Battery Service**  
Charge battery, clean cable connections at battery ..... \$35.00 Each Battery
- Battery Replacement**  
Remove the existing battery and install the New Battery..... \*Time and Material

## ANODES /ZINCS

- Outboard Motor Anode Replacement (Not needed when selecting a Tune-Up)**  
Remove and replace anodes on the motor lower unit and transom assembly..... **\$165.00 + Parts Per Motor**
- Inboard Boats Hull and Running Gear Anode Replacement** ..... \* **Time and Material**
- Sterndrive Boat Anode Replacement** ..... \* **Time and Material**

## TUNE-UP

- Outboard Motor Tune-up**  
Spark plugs, fuel filter, water separating fuel filter, alternator belt adjustment, lubricate linkages and control cables at motor attachments, grease lubrication points, check fluid levels, and replace anodes.  
175 HP and under ..... **\$250.00 + Parts ea.**  
Over 175 HP..... **\$295.00 + Parts ea.**
- Sterndrive/Inboard Gasoline Engine Tune-Up**  
Spark plugs, replace primary & secondary fuel filters, replace engine cooling system sacrificial anodes, adjust engine belts, replace distributor cap and rotor, adjust ignition timing and carburetor, check fluid levels..... **\$375.00 + Parts ea.**
- Diesel Engine Service Tune-Up**  
Clean/replace intake air filter, adjust auxiliary belts, replace primary and secondary fuel filters replace sacrificial anodes, check fluid levels ..... **\$560.00 + Parts**
- Generator (Gas or Diesel) Units Tune-Up**  
Change primary and secondary fuel filter, belt adjustment, cooling system corrosion anode, fluid check  
Ignition cap, rotor,points and plugs (Gas models) check voltage at panel ..... **\$295.00 + Parts**

## DE-WINTERIZING (Not needed when selecting a Tune-Up)

- De-Winterizing Outboard, Inboard, or Sterndrive Gas Motor**  
Check engine oil, start motor, bring up to temp, and check shift..... **\$150.00 ea. Plus Fluids**
- De-Winterizing Diesel Engine**  
Check engine oil, start motor, bring up to temp, and check shift..... **\$165.00 ea. Plus Fluids**
- De-Winterizing Generator**  
Fluid check, Start unit check for power at breaker panel ..... **\$125.00 Plus Fluids**

## ONBOARD SYSTEMS COMMISSIONING

- Onboard Water Systems Commissioning**  
Flush water tank, commission head, washer/dryer, shower sump, washdown, transom showers, fish boxes live well pump, cockpit sinks, ice maker  
Boats up to 28' ..... **\$175.00**  
29' to 38' ..... **\$310.00**  
39' and up..... **\$495.00**
- Air Conditioning System Commissioning**  
Bleed cooling water system, check for water leaks, energize unit ..... **\$98.00**  
Additional zone(s)..... **\$24.00 ea.**
- Eskimo Ice Maker Commissioning**  
Flush water system, replace water filter, run unit, check for leaks..... **\$165.00 + Parts**
- Gyro System Commissioning**  
Check fluid levels, bleed cooling water system, perform unit start-up ..... **\$165.00**

## DETAILING SERVICE

The costs are based on the overall length of the boat

- Center Console/Cruiser/Walk Around or Express Boats**  
Exterior wash, wax hull, topside, and cockpit. Machine buff, clean cushions, and compartments ..... **\$43.00 per ft**
  - Hard Top/Bridge Boats**  
Exterior wash, wax hull, topside, cockpit, and hard top/bridge. .... **\$47.00 per ft**
  - Wax Hull**  
Wax hull (rub rail to waterline) machine buff. .... **\$22.00 per ft**
  - Compound Hull Only** (we will notify you if this is needed)..... **\$8.00 per ft**
  - Compound Topside Only** (we will notify you if this is needed) ..... **\$10.00 per ft**
- Note:** In cases of heavy oxidation the compounding procedure may not restore the finish completely.

## RUN BOAT TO IT'S SLIP (in Clarks Landing)

- Temporary Tie Up in Slip (See Note #5)**  
Relieves the customer from being present at launch (lines and fenders must be onboard or at slip)..... **\$95.00**
- Environmental Compliance/Shop Supplies (See Note # 12)**..... **\$75 .00**

### NOTES

1. All accounts must be paid in full prior to launch, including your Spring Launch work orders.
2. Boats were put on land according to the date you requested to be re-launched on your winter storage contract. Please make sure you have completed any work that needs to be done prior to this date. If you change this date, there may be a charge if your boat needs to be moved. We will do our best to accommodate you. Due to uncontrollable forces (i.e. weather) Clarks Landing Marina cannot guarantee the exact date your boat will be launched.
3. Boat bottoms will be painted the same color as the existing color with Sea Hawk bottom paint. If you would like a different color you must indicate in the space provided under bottom paint. A half hour free scraping charge is included. If additional time is required, you will be notified.
4. Clarks Landing has been recognized by the NJ Department of Environmental Protection as a New Jersey Clean Marina. This requires the following procedures be adhered to:
  - a. Boat owners are not permitted to scrape, sand, or bottom paint their boats while on marina property. The material is considered hazardous waste.
  - b. **Waste oil disposal.** Clarks Landing provides a waste oil tank for customer use via the service department. Oil filters are to be drained completely on the rack provided. Under **no** circumstances shall oil filters be disposed of in Clarks Landing trash bins.
  - c. Clarks Landing has the right, but not the obligation to clean up any violations and bill the responsible party and/or boat owner accordingly.
  - d. Customers removing their own shrink wrap must remove the material from marina property.
  - e. Ethyl Glycol permanent anti-freeze must be recycled. If discharged onto the ground, responsible party and/or boat owner will pay for clean up and any fines incurred.
5. Temporary slip tie-up: Customer does not have to be present at time of launch. Clarks Landing Marina will notify owner when boat is launched and moored in slip. Owner to adjust lines within 24 hours of boat being launched. Mooring lines must be in the boat prior to launch date. If lines are missing or in questionable condition, new lines will be installed (2 bow, 2 stern, 2 spring lines) and billed to the customer.
6. A minimum of three (3) days prior to tentative launch date, boat owner must drop off a spare set of keys to ignition and all locks on-board.
7. Clarks Landing assumes no responsibility for damage to canvas, isinglass, zippers tracks, stitching or fasteners, during Winter Storage or installation process as this is generally an indication of aged or degraded material. The customer will be contacted in the event the enclosure is found to be in need of repair.
8. Boats remaining on land or in the water for more than 3 days after completion of the work will be subject to a storage fee of \$2.00 per foot per day.
9. The trash bins and dumpsters at Clarks Landing are for trash generated while at the marina. Hazardous material may NOT be disposed of on Marina property (including batteries). You can not bring your trash or anything else from outside and dispose of it on marina property. You will be responsible for the cleanup costs of any hazardous material deposited in these receptacles or on marina property along with any fines or penalties.
10. Sandblasting is not permitted on Clarks Landing Marina property.
11. We will not commission any engine not winterized by Clarks Landing Marina.
12. This fee is added to your bill to offset expenses incurred for disposal of waste fluids and chemicals, recycling, and miscellaneous shop supplies.

**ACKNOWLEDGEMENT**

By signing below, I hereby authorize the completion of service work, including labor and materials. I understand that my boat will not be launched or released from the Marina or Winter storage until all bills are paid in full. I authorize Clarks Landing employees to operate my boat for purposes such as testing, placing it in a slip, or delivery, at my risk.

Clarks Landing shall not be held responsible for any loss or damage to the boat and/or articles left on the boat, including but not limited to fire, theft, accidents, or other causes. An express mechanic's lien is acknowledged on the boat to secure payment for repairs and services. Manufacturer warranties constitute the only express and implied warranties for the sale of engines, parts, and accessories. I confirm that, while the boat is moored or stored on land at the Marina, I will maintain an active marine insurance policy, including protection and indemnity liability coverage, with limits of no less than Five Hundred Thousand Dollars (\$500,000.00) per occurrence. The insurance policy will name Clarks Landing Marina as an additional insured. If the vessel is operated as a charter, I acknowledge that additional insurance requirements, as outlined in the slip contract, must be adhered to accordingly.

I agree to abide by Clarks Landing's rules and regulations and confirm that I have read and agreed to the terms, conditions, and prices as stated in this Spring Launch Program.
